- Member of the House of Delegates

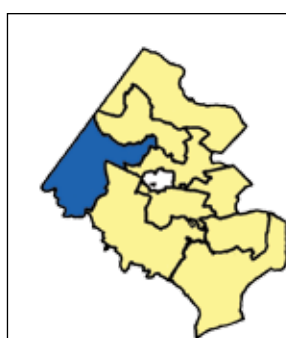

This 2011 *Voter's Guide* is an effort to familiarize voters with the well-qualified Democratic candidates seeking these offices.

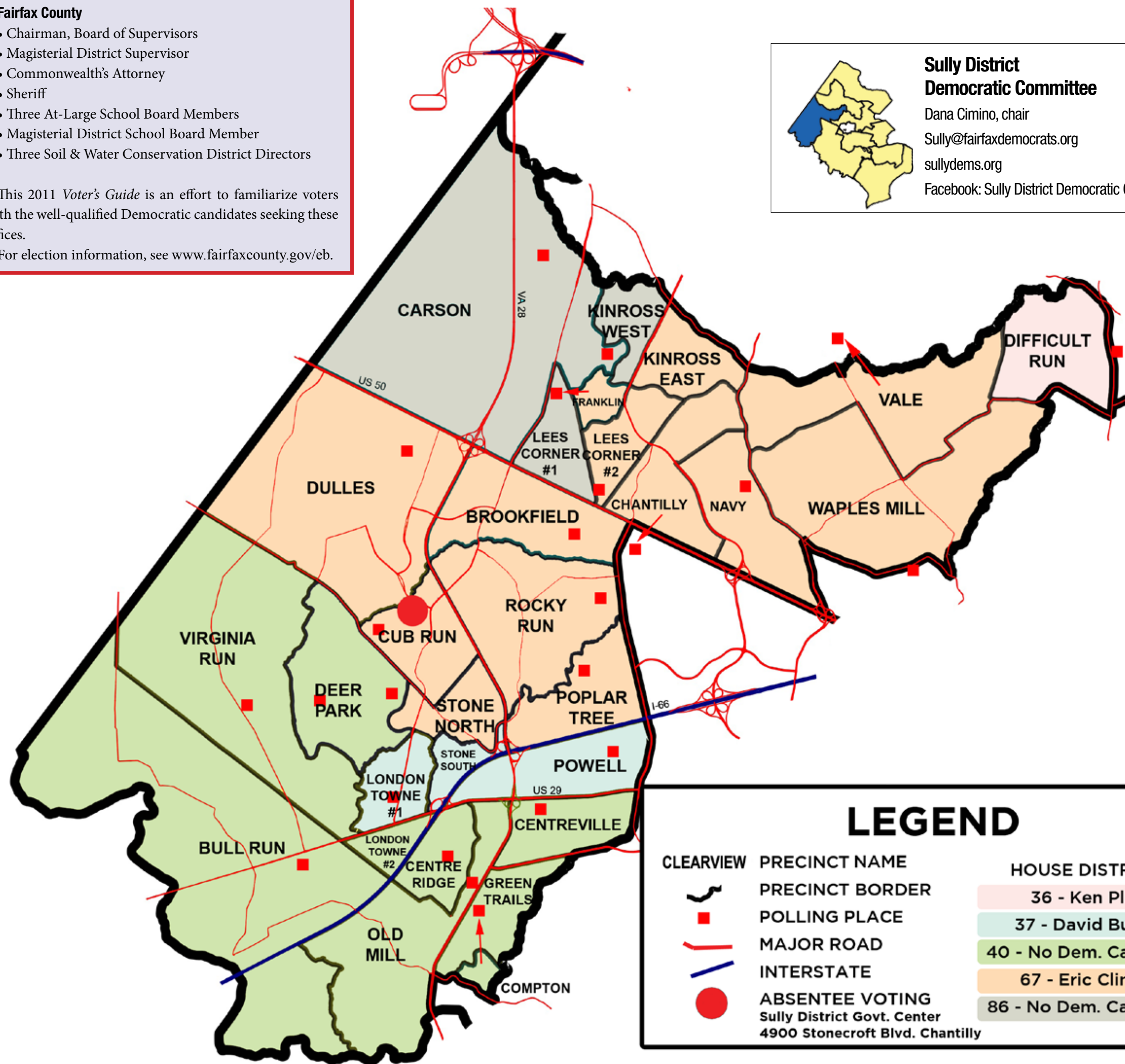
