

# Nomination Form to be Completed by Persons Recommending Candidates Subject to the Hatch Act for FCDC Endorsement for Council of Town of Herndon - General Election – November 6, 2018

A Candidate subject to the Hatch Act may not personally request endorsement of his/her candidacy by the Fairfax County Democratic Committee (FCDC). In such cases an FCDC member may submit the name of a candidate to be considered. Requests for endorsement require submission of this Nomination Form & Questionnaire along with a \$250 filing fee\* (to be paid by the parties submitting the nomination) to the FCDC office by 5:00 p.m. eastern daylight time May 10, 2018. The office address is 8500 Executive Park Ave., Suite 402, Fairfax, VA 22031.

*\* The filing fee will be refundable in full to the payor(s) of the fee in support of a candidate who is the winner of the endorsement, and to the payor(s) of the fee in support of any other candidate that sought the endorsement upon providing proof that the candidate has withdrawn from the race. Payor(s) of the fee in support of any candidate that does not receive the endorsement and fails to withdraw from race shall forfeit the \$250 which will be divided evenly and then provided to the winners of the endorsements as a contribution from FCDC.*

The submitting/paying FCDC member understands and agrees:

- that completion and submission of the application and questionnaire does not guarantee that any endorsement shall be provided to the supported candidate;
- that submission of the application and filing fee entitles the submitting/paying FCDC member access to the FCDC membership roster (name, address and phone number only; no email addresses) solely in support of, and without coordination with, the candidate;
- that endorsement is granted at the sole discretion of FCDC; and
- to adhere to the rules and procedures governing the selection process for candidates for whom the FCDC member seeks endorsement by FCDC for Council of Town of Herndon.

A candidate subject to the Hatch Act who receives the endorsement of FCDC is eligible to receive the following benefits without coordination with the candidate or his/her campaign:

- Possible campaign contributions from FCDC
- Inclusion on the Democratic Sample Ballot and other campaign materials as may be developed by FCDC

One of the primary functions of the FCDC and the Magisterial District Committees is the support and election of Democratic candidates to all levels of public office. Therefore, any candidate who does not receive the endorsement of FCDC WILL NOT be eligible for the above benefits. No FCDC or Magisterial District resources will be used in the support or promotion of any unendorsed candidate.
